Dear Mr. Powers, Esteemed Members of the Greenwood Leflore Hospital Board and CEO:

A majority of the Leflore County Board of Supervisors would like to express our concerns, on the perceived notion of an antagonistic attitude and lack of communication with the majority of the County Board of Supervisors. We requested a meeting with you to discuss the financial aspects, the budget and any strategic plan(s) you may have compiled for the future operation of Greenwood-Leflore Hospital. That meeting never materialized, but the requested information was readily available and given to the *Greenwood Commonwealth*.

The Leflore County Board of Supervisors recognizes the need for confidentiality in some instances dealing with Greenwood-Leflore Hospital; however, as co-owners of the hospital, when we request information, we expect to get it. Therefore, a request is hereby made to update the Leflore County Board of Supervisors on the status of any and all negotiations made with any other health care institution to "take over" the operation of the hospital, who is involved in those negotiations and the content of any contractual obligations, if any. A representative of the Leflore County Board of Supervisors will be appointed to contact the University of Mississippi Medical Center and the Baptist Hospital concerning this matter if we have not heard from you before June 6, 2022.


